- We discussed removing the benches entirely. I'd prefer not to do this as they are appreciated by bus passengers. I'd prefer to fit them with arms.

- The proposal for deep cleaning the shelter is welcomed. I guess we need to have an internal discussion about where the money to do this comes from.
- One of the reasons the shelter is in such poor condition is that, for at least a couple of years, it's been under threat of imminent demolition firstly because the building it's attached to was about to be converted to flats, and now a hotel. We are working with the hotel company on a new shelter (which we have planning permission for). The current proposal is that the existing shelter will come down when the hotel company put scaffolding on the front of Roman House, but we don't have a date for that yet.

We are starting our "once a week" wash down of the snickleways next week, i will put the shelter on the list.

However, we use cold water and jeyes fluid, it needs a good steam clean at least once a fortnight using very hot water.

That is something that cost involved.

The place is a "dump" and always will be, from 6am you start to get your bus passengers, from 8am you get your school kids, from 10am you get bus drivers milling around the place, from noon you get the street drinkers, from 3pm you get the kids en-route home, from 5pm you get people going home, from midnight you get the place doubling up as a (legal) taxi rank etc.

All these people drop litter/smoke/throw up/emit bodily fluids etc, its no wonder the place is as bad as it is.

We sweep it around 5am 7 days a week (mechanically and manually) as from next week it will be washed /disinfected once a week, it is swept around 4pm Mon to Fri, there is not a lot more i can do, i really don't have the manpower or resources to offer more.

I just hope the planned extension of the hotel will pull the place down and take away the horrible shelter.

Sorry if i sound negative but this place, along with High Ousegate lane has been the bane of my CYC life for far too many years!

Hello, just to confirm ______ comments below, we had a meeting about the use of Community Protection Notices (CPN) for ASB, the NEO's have the power to issue warnings, CPN's and also fixed penalty notices or prosecute if there are ongoing issues in accordance with the new ASB legislation. We have set up within the Hub an initiative for beggars, but at the meeting yesterday we felt that maybe that initiative could be considered for all issues on the streets, such as begging, street drinking, ASB on streets, etc.

The use of an initiative or step by step guidance allows for officers to be able to look to the new powers and use them effectively and proportionately, but also, if we get to a court scenario we can easily and quickly set out to the court the process we follow before we get to their door, which will assist with some of the judges we've had recently.

we are looking to roll out an input to the City SNA, to deal with begging, but if is happy for us to roll out the begging initiative as a general street initiative, then we can speak to the team about that approach too. We can also speak with the officers covering the Groves too so that we have a set approach to tackle these general ASB issues.

I had a look at this today and broadly agree with what you suggest below, with a couple of small additions:

- Given the volume of passengers waiting under the canopy on the Station frontage, can we provide more seating than currently (at the moment there are (I think) three benches – so a seating capacity of 12, which is clearly less than the number of people waiting)? I agree we should use the new standard design – with armrests.
- 2. As you suggest, in the tram shelter, the bench appears to be the original, so I agree we should look at fitting this with armrests first rather than replacing it.
- 3. Yes, I think we should repaint the tram shelter presumably it's a fairly low cost thing to do and appropriate if we are going to provide bus information there, archive photos etc. We should also take the opportunity to tidy the structure up more generally removing redundant lighting fittings, bells etc.

Hi

I have met with _____ and PC ____ this afternoon to discuss the issues with rough sleeping and drinking at the station.

The main issue have is the attraction of the benches, both in the tram shelter and under the station canopy. They would rather benches were removed altogether but recognise they are an amenity for bus users. Therefore I propose that the bench in the tram shelter has arm rests added to it to deter people from lying down and that the benches under the station canopy are changed to the new type being installed in the city centre, with arm rests, again to deter lying down.

The tram shelter needs the paving replacing within it to make cleaning easier, there are gaps between flags that trap litter, and broken flags. I propose that bright lighting is used and that bus information is mounted on the side walls, and some archive pictures placed along the back wall, to encourage use by more people and also reduce graffiti on the stonework. The shelter itself would benefit from repainting although actually is not in bad condition and this is not vital.

If you have any further ideas let me know and I will begin to get this organised.

- Engaging with the individuals in question is difficult because they have entrenched patterns of behaviour which are very resistant to change.
- NYP are happy to disperse these individuals when they are causing a nuisance.
 Drivers/ Bus Wardens etc shouldn't engage with them, but the Police will move
 them on if notified by a call to 101. As such, whenever there is a problem I'd
 advise staff to raise this with NYP.
- In the short term, I have asked for arms to be fitted to the benches at Rougier Street and for the areas beneath the benches to be boxed in. This should happen in the next 2 weeks and will make the Rougier Street shelter a less attractive place for people to sit in for long periods of time.

We are also intending to redevelop the shelter at Rougier St. I am going to speak to who is the architectural liaison officer at NYP about how the detailed design of the new shelter can minimise anti-social behaviour inside it. I am hoping that the existing shelter will have gone in 6 months and the new shelter will be in place in 12 months. Whilst the building work for the Cedar Court's extension is taking place, I'll assume that the anti-social behaviour problems will go away because the stop will be very noisy/ busy.

My team doesn't have any powers to move people along. It can, however, look at how we can improve matters at this location.

Clearly one solution would be to remove the old tram shelter completely (as I suspect that this is the particularly problematic factor). As the shelter is of 'historical interest', however, this is unlikely to be a measure meeting with approval from our conservation colleagues.

Through the 'Better Bus Area' funding we have available (in the current financial year), we are working with Property Services colleagues to design improvements to the look and feel of the old tram shelter. Provisionally, this would include lighting as well as real time and static information displays. I'm not sure what you can do about people urinating behind the shelter, but it should help to encourage more bus passengers into the shelter, which would hopefully serve to put off sleepers/drinkers, etc.

Street Environment are receiving more and more complaints about the rough sleepers/drinkers that sit in the bus shelter opposite York Station. My understanding is that they are there from early in the morning and then throughout the day.

This is causing the following problems:-

Abuse towards people waiting for buses
